

Temperature




Fig. 3 Peak Emission Wavelength vs.
Ambient Temperature




Fig. 5 Relative Radiant Flux vs. Ambient Temperature




Fig. 2 Relative Radiant Intensity vs. Wavelength




Fig. 4 Forward Current vs. Forward Voltage





Fig. 6 Relative Radiant Intensity vs.

Angular Displacement






## **Gull Wing Lead Configuration**
